All past due amounts are subject to a service charge of One and a half percent (1.5%) per month.

WARRANTY: The Applicant's sole and exclusive warranty, if any, is the warranty provided by the Product's Manufacturer. SELLER MAKES NO EXPRESSED OR IMPLIED WARRANTIES. SELLER HEREBY DISCLAIMS ALL EXPRESSED OR IMPLIED WARRANTIES, WHETHER IMPLIED BY OPERATION OF LAW OR OTHERWISE, INCLUDING WARRANTIES OF MERCHANTABILITY AND FITNESS OR FITNESS FOR A PARTICULAR PURPOSE. UNDER NO CIRCUMSTANCES, WILL SELLER BE LIABLE FOR INCIDENTAL, PUNITIVE, SPECIAL OR CONSEQUENTIAL DAMAGES OF ANY KIND. SELLER'S LIABILITY, IF ANY, SHALL BE LIMITED TO THE NET SALES PRICE RECEIVED BY THE SELLER.

NOTICES: The Applicant shall notify Myers-Cox in writing of any material change in the information provided herein, including, but not limited to, change of Applicant's address, or if the business or any interest therein of Applicant's is sold, or if any adverse change occurs in Applicant's financial condition.

WITNESS, NOW, THEREFORE, as an inducement to Creditor to grant credit, or assume a credit risk and for other good and valuable consideration, it is agreed as follows:

- 1. The undersigned Guarantors shall pay to Creditor forthwith when due, or upon demand thereafter, including finance charges, and without deduction for any claim of set-off or counterclaim of the Customer or loss of contribution from any co-guarantor the full amount of all obligations of indebtedness due to Creditor from the Customer, together with all expenses of collection and reasonable attorney's fees incurred by Creditor by reason of the default of the Customer. The obligation of Guarantors shall cover (and receipt of notice of termination shall not affect) the renewal of claims guaranteed and covered by this instrument or extensions of time of payment thereof and shall not be affected by an surrender or release by Creditor of any other security held by it for any claim or debt hereby guaranteed.
- 3.
